The applicant is an aspirant for selection and  
appointment to the post of Extra Departmental Branch  
Postmaster, Mannakanadu post office. She seeks for a  
declaration that she is entitled to be considered in the  
selection of EDBPM, Mannakanadu post office and for a  
direction to the 1st respondent to consider the applicant  
also along with the Employment Exchange sponsored  
candidates in the interview scheduled to be held on  
13-4-1998. She has made her representation dated 16-3-98  
(Annexure A-2).

2. When the application came up for hearing, learned counsel appearing for respondents states that in view of the ruling of the Hon'ble Supreme Court in Excise Superintendent, Malkapatnam, Krishna District, A.P. Vs. KBN Visweshwara Rao, (1996) 6 SCC 216, the respondents would consider the candidature of the applicant also for selection and appointment to the post of Extra Departmental Branch Postmaster, Mannakanadu Post Office.

3. In view of what is stated above, we dispose of this application with a direction to the 1st respondent to consider the candidature of the applicant as valid for selection and appointment and to consider her in the interview which is scheduled to be held on 13-4-1998, to the post of Extra Departmental Branch Postmaster, Mannakanadu Post Office, though her name may not be sponsored by the Employment Exchange.

4. Learned counsel for respondents undertakes to intimate the department of this order forthwith. No costs.
