The application having been heard on 15-4-1997, the
Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR. PV VENKATAKRISHNAN, ADMINISTRATIVE MEMBER

Applicant who is working as casual labourer in the
Postal Department, made a representation A-4 requesting
respondents to consider him for appointment as Extra
Departmental Packer at Punnapra North Post Office. There
is no response to this representation. However, by an
earlier letter (A-1) applicant had been informed that he
cannot be considered for regular selection to any Extra
Departmental post since the selection is to be made only


from the list of candidates sponsored by the Employment Exchange. Applicant prays, therefore, that he may be considered for selection as Extra Departmental Packer, even though his name has not been sponsored by the Employment Exchange, in the light of the judgment of the Supreme Court in Excise Superintendent, Malkapatnam, Krishna District, A.P. Vs. K.B.N.Visweshwara Rao & Others, (1996 (6) SCC 216).

2. Learned Standing Counsel for respondents submits that applicant will be considered for the selection to be conducted to the vacancy of Extra Departmental Packer at Punnapra North Post Office, even though his name has not been sponsored by the Employment Exchange, in view of the decision of the Supreme Court referred to above.

3. We accordingly direct the first respondent to consider the candidature of the applicant also along with other eligible candidates for the selection to the post of Extra Departmental Packer, Punnapra North Post Office.

4. Application is disposed of as aforesaid. No costs.
