O R D E R

The applicant seeks to declare that he is entitled to
be treated as Government servant with effect from 1.10.1991,
that he is entitled to be considered for temporary status,
to direct the respondents to consider his claim, and also
to direct the 3rd respondent to dispose of A8 representation.

2. The applicant says that he is working as Wash Boy in
the non-statutory unregistered Departmental Tiffin Room


attached to the office of the 1st respondent from 1985 onwards. A1 to A1(i) and A9(a) to A9(o) are the copies of payment vouchers for the period from 1985. Since the applicant was not conferred with temporary status, he submitted representation before the concerned authority for redressal of his grievance.

3. When the OA came up for hearing, the learned counsel appearing for the respondents submitted that A8 representation still remains undisposed of. The learned counsel for the applicant submitted that at this juncture it is suffice to direct the 3rd respondent to dispose of A8 representation within a reasonable time.

4. Accordingly, the 3rd respondent is directed to dispose of A8 representation dated 19th of February, 1996 within ten weeks from today by a speaking order.

5. The original application is disposed of as above.
No costs.
