Tribunal on the same day delivered the following :-

ORDER

HON'BLE Dr.K.B.S.RAJAN, JUDICIAL MEMBER

This case relates to inter-divisional transfer to Trivandrum Division of
Assistant Loco Pilots.

2. Earlier all such cases were considered when the Chief Personnel Officer, Southern Railway was present in the Court and an agreement was reached that in phased manner all such transfers should take effect ensuring that such transfers should be prior to direct recruitment in the

Trivandrum Division. In pursuance of the same, the Chief Personnel Officer had taken up the matter with the concerned Divisional Manager, Palakkad vide D.O letter dated 11.3.2013 in which the following has been incorporated :-

" However taking into account the assurance which has been given to Hon'ble Central Administrative Tribunal, Ernakulam I would request you to kindly ensure atleast first 50 registrants who are in Trivandrum waiting list may kindly be considered for transfer after the fresh set of ALPs join working post.

The break up of the first 50 applicants from various Divisions to Trivandrum Division as per priority maintained at TVC is as follows :

Madurai Division	-	3
Palghat Division	-	16
Tiruchi Division	-	4
Chennai Division	-	13
Total		36

Others are Inter Railway Transfer registrants.

I am also enclosing a statement showing the Inter Divisional transfer request of ALPs from one division to other and as there are sizable request to PGT division from Salem Division the same also has to be considered to ensure equitable distribution.

RRB/Chennai will be supplying ALP papers by end of March, 2013 with which we will be able to reduce the existing vacancy by more than 50%.

As far as possible while considering the relief of the employee, the relief should be made as per priority registration to avoid grievance of the employee with regard to loss of seniority."


3. The above order appears fully justifiable and if implemented in toto the same would redress the grievance of all the persons.
