The application having been heard on 11-8-2004, the
Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR. A.V. HARIDASAN, VICE CHAIRMAN


Applicants, who are working in NAD, Aluva under the Ministry of Defence, are aggrieved that, though they are involved in hazardous nature of work for which risk allowance is to be granted as per Annexure A1 order and though similarly situated persons are given the risk allowance, their request for award of the same has not been considered and decided. Therefore, the applicants have filed this application jointly for a direction to the respondents to extend the benefit of Annexure A1 to them with effect from 22-5-2002 onwards and disburse to them the arrears at the earliest.

2. When the application came up for hearing, learned counsel on either side suggest that the application may be disposed of permitting the applicants to make a detailed representation to the 1st respondent in regard to their grievance of not extending the risk allowance to them and directing the 1st respondent that if such a representation is received, the same shall be considered and disposed of within a reasonable time.

3. In the light of the above submission by the learned counsel on either side, the Original Application is disposed of permitting the applicants to make a detailed representation to the 1st respondent projecting their grievance which has been stated in this application within two weeks and directing the 1st respondent that if such a representation is received the same shall be considered and appropriate reply given to the applicants within a period of four months from the date of receipt of the representation. No order as to costs.
