The application having been heard on 17.4.98, the Tribunal  
on the same day delivered the following:

O R D E R

HON'BLE MR. A.V. HARIDASAN, VICE CHAIRMAN

The applicant is an aspirant for the post of Extra  
Departmental Delivery Agent, Helibria Post Office. He  
apprehends that his candidature may not be considered by the  
respondent for the reason that his name may not be sponsored  
by the Employment Exchange. Hence he has filed this  
application for a declaration that he is entitled to be  
considered for regular appointment to the post of Extra  
Departmental Delivery Agent, Helibria Post Office  
notwithstanding non-sponsoring of the name by the Employment  
Exchange and for a direction to consider his candidature

also alongwith those sponsored by the Employment Exchange. The applicant has submitted an application dated 1.4.98 (A.1) for this purpose.

2. When the application came up for admission today, Shri George Joseph, ACGSC appearing for the respondent submitted that in view of the ruling of the Hon'ble Supreme Court in Excise Supdt. Malkapatnam, Krishna Dist. A.P. Vs. KBN Visweswara Rao and Others, (1996 (6) SCC 216), the candidature of the applicant also would be considered as valid for selection. Learned counsel for applicant submits that the applicant would be satisfied if a direction is given for ~~xxx~~ considering his candidature also in the interview scheduled to be held on 20.4.98.

3. In the light of what is stated above, the application is disposed of with a direction to the respondent to consider the candidature of the applicant also in the interview scheduled to be held on 20.4.98 or any deferred date for selection and appointment to the post of Extra Departmental Delivery Agent, Helibria Post Office even though his name may not be sponsored by the Employment Exchange. There is no order as to costs.
