

These applications having been heard on 25th July 2007 the Tribunal on the same day delivered the following :-

ORDER

HON'BLE MRS.SATHI NAIR, VICE CHAIRMAN

Applicants in these O.As had approached this Tribunal impugning the order of the respondents in Annexure A-11 and Annexure A-9 putting them on notice that appropriate action would follow in their cases as the Tribunal in O.A.1689/98 had quashed the entire selection to the cadre of Postal/Sorting Assistant made in the year 1998. Respondents had filed a reply statement stating that the impugned order was issued on the basis of a direction of the Tribunal in the said O.A and that they had filed OP Nos.15382/01 and 19088/01 which has been pending before the Hon'ble

High Court of Kerala. Since the Hon'ble High Court had given an interim stay in the matter this case was adjourned. These O.As were adjourned sine die awaiting the decision of the Hon'ble High Court. It is submitted by the learned senior counsel that the Hon'ble High Court has now allowed the two O.Ps vide order dated 5th December 2006 and set aside the order of the CAT in OA 1689/98 and the matter is being taken before the Hon'ble Supreme Court and therefore he would like to withdraw the O.A keeping all contentions open. In the light of the order of the Hon'ble High Court setting aside the CAT order in OA 1689/98 further action by the respondents as per impugned orders at Annexure A-11 and Annexure A-9 of these O.As has to abate. The O.As have thus become infructuous. Applicants are permitted to withdraw these O.As with the liberty to approach the Tribunal later, if necessary.
