on par with their juniors who are drawing more pay than them.



The applicants are permitted to submit representations through proper channel to the Director General of the concerned department except in O.A. 944/95 in which case the representations shall be submitted to the second respondent within one month from today. If such representations are received, the Director General of the concerned department/second respondent in O.A. 944/95 shall consider and dispose of the representations by reasoned orders within three months from the date of the representations.
