O R D E R

HON'BLE MR AV HARIDASAN, VICE CHAIRMAN

The applicant who is presently working as a Part-time  
Sweeper in the Postal Department for the last 14 years, is a  
candidate for selection and appointment to the post of Extra  
Departmental Delivery Agent, Azheekal P.O. She has submitted  
a representation on 10.12.97. Apprehending that the respondents  
would make the selection ignoring her preferential claim, based  
on the instructions of the Director General, Department of Posts

letter dated 6.6.88 A-4, the applicant has filed this application for a declaration that she is entitled to be considered for appointment to the vacancy of EDDA, Azheekal.P.O. under the 1st respondent on a preferential basis in accordance with the provisions contained in A-4, and for a direction to the 1st respondent to consider her for such appointment accordingly.


2. When the application came up for hearing, learned counsel of the respondents states that the respondents would consider the case of the applicant for appointment to the post of EDDA, Azheekal.P.O. taking into account all the Departmental instructions and the rules including A-4 and make a final selection.

3. In the light of what is stated above, the application is disposed of directing the respondents to take a decision regarding selection and appointment to the post of EDDA, Azheekal P.O. considering the case of the applicant in the light of A-4 circular and other orders, rules and instructions on the subject.
