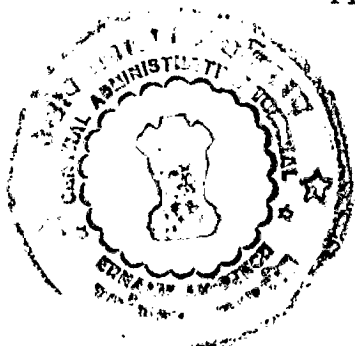

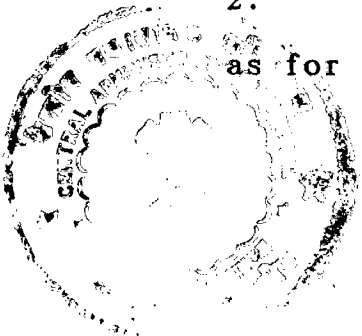
The application having been heard on 21.8.2000, the Tribunal
