

This application having been heard on 24<sup>th</sup> October 2008 the Tribunal on the same day delivered the following :-

**ORDER**

**HON'BLE Mr.GEORGE PARACKEN, JUDICIAL MEMBER**

The applicant has filed this O.A challenging Annexure A-7 letter dated 14.11.2007 which has been issued to him by the respondents in reply to his representation dated 27.7.2007 regarding the promotion of some of his juniors as Drivers in MMS. Respondents along with their reply

statement produced Annexure R-1 Circle Gradation List of MMS staff as on 1.7.2002. According to the applicant, the aforesaid list is defective as some of his juniors have been shown senior to him. Shri.P.C.Sebastian, counsel for the applicant, submitted that he could challenge the impugned order in the present O.A successfully only if the aforesaid seniority list is also challenged and got it rectified. He has, therefore, requested to permit him to withdraw the O.A.

2. The counsel for the respondents has also no objection to permit the applicant to withdraw the O.A.

3. Accordingly, we dismiss this O.A as withdrawn. There shall be no order as to costs.
