The application having been heard on 16.1.1998, the
Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR. A.V. HARIDASAN, VICE CHAIRMAN


Applicant who is presently working as Extra Departmental
Delivery Agent, Paduvapuram on promotion of the regular
incumbent as Postman, has applied on 9.1.1998 (A2) for
regular selection and appointment to that post, coming to
know that steps are in progress for making regular
appointment. As had been informed by the respondent that
-xxxx those who have been sponsored by the Employment
Exchange only would be considered, the applicant has filed
this application for a declaration that he is entitled to
be considered for selection though not sponsored by the
Employment Exchange and for appropriate direction to the
respondents.

2. When the application came up for hearing, learned counsel for the respondents fairly conceded that in view of the ruling of the Hon'ble Supreme Court in Excise Supdt. Malkapatnam, Krishna Dist. A.P. Vs. K.B.N. Visweswara Rao and others, 1996 (6) SCC 216, the applicant is also entitled to be considered and that the respondents would consider the candidature of the applicant also though not sponsored by the Employment Exchange.

3. In the light of the submission of the learned counsel for the respondents, we dispose of this application with a direction to the respondents to consider the candidature of the applicant also as valid for selection and appointment and consider him in the selection for the post of Extra Departmental Delivery Agent, Paduvapuram though his name may not be sponsored by the Employment Exchange. No order as to costs.
