Applicants who describe themselves as skilled workers, dissatisfied with their scale of pay have approached this Tribunal for redress. They submit that those who do similar work elsewhere are paid much more.

2. It is not for this Tribunal to adjudicate on such matters. Applicants have made a representation in this behalf, but to the wrong authority. If they are so advised, they may set out their grievances in the form of a representation and make it before second respondent within one month. If a representation is so made, second respondent will take such action as he considers appropriate. We do not indicate the course of action to be taken nor do we express any opinion on the merits of the claim made by applicants.

3. Application is disposed of as aforesaid. No costs.
