
The applications having been heard on 17.4.96 the Tribunal

O R D E R

CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN

Applicants in these three cases, challenge the transfer  
of common respondent-CJ Varghese to Trivandrum. According to  
them, respondent-CJ Varghese is favoured by second  
respondent(O.A.1523/95).

2. Applicants submit that there are other vacancies at  
Trivandrum even after posting CJ Varghese and that they could  
be considered for those vacancies.
3. We do not propose to interfere in a matter of transfer  
like this. If at all, the matter may be considered by the



respondent-Director, National Sample Survey Office, (Field Operations Division), C.Block, IIIrd Floor, Pushpa Bhavan, New Delhi. Applicants may make representations before the aforesaid respondent within two weeks from today and that respondent will consider the matter on its merits and take a decision. While doing so, he will not consider the recommendations or views of Shri G Sajeevan, Regional Assistant Director, National Sample Survey Office, Trivandrum. We make it clear that we do not attribute any malafides or motivation to respondent-Sajeevan. If no such representations are made within two weeks from today, this order will stand recalled and the Original Applications will stand dismissed. Status quo as on today will be maintained in respect of applicants and party respondents, till a decision is taken and thereafter the matter will be governed by the decision.

4. Applications are disposed of as aforesaid. No costs.
