
Applicant who is working as a Junior Engineer Grade-I at Palghat submits that by A-4 he had registered for transfer to Calicut which has the priority of A-2 dated 8-7-1992. Applicant is aggrieved by the transfer of 5th respondent to Calicut. He submits that according to the policy adopted by the Railways, persons waiting for transfer on request have to be first accommodated before vacancies are filled up by other candidates.

2. It is for the respondent Railways to consider such grievances of the applicant in the first instance.

Applicant may make a representation to the first respondent within three weeks of today. If such a representation is made, the first respondent will consider it in the light of the existing instructions in the matter and pass appropriate orders thereon within two months of the date of receipt of the same.

3. Application is disposed of as aforesaid. No costs.
