The application having been heard on 23.1.2001, the Tribunal on the same day delivered the following:

#### O R D E R

HON'BLE MR. A.V. HARIDASAN, VICE CHAIRMAN

Applicants 48 in number are members of the Fire Force of the Lakshadweep Administration. They are in three grades. Their common grievance is that they are left at lower pay scales in comparison to their counterparts under the Delhi Administration as also Union Territory of Andaman and Nicobar Islands. Despite the

fact that the applicants have highlighted the grievance before the second respondent several times, applicants are still aggrieved that their request have not evinced any response. Under these circumstances, the applicants have jointly filed this application for the following reliefs:

- (i) to declare that the applicants in the category of firemen in the Union Territory of Lakshadweep are entitled for a pay scale of Rs.975-25-1150-EB-30-1660+300 and the category of driver operator the pay scale of Rs.1320-2040+300 as that of the firemen and drivers and firemen operator drivers in Delhi, Andaman and Nicobar and other Union Territories;
- (ii) to direct the respondent No.2 to dispose of Annexures.A5 to A9 within a time limit.
- (iii) to direct the respondents to consider the training period of the applicants as active service and extend the benefit of Annexure.A2 to the applicants.
- (iv) to direct the respondents to give compensatory off, overtime allowance, risk allowance, remote area allowance and accommodation to the applicants are given to other fire service personnel,
- (v) to issue such other reliefs which this Hon'ble Tribunal may deem fit and necessary in this case.

- (vi) to award the costs of the applicants.

2. The respondents have filed a detailed reply statement in which they contest the claim of the applicants.

3. When the matter came up for final hearing, learned counsel for the applicant states that the applicants would be satisfied if the applicants are permitted to make a detailed representation to the 1st respondent and the 1st respondent is directed to look into the matter and give an appropriate reply to the respondents within a reasonable period. Ms. Heera appearing for the respondents submits that the respondents have no objection if the matter is being disposed of in the said manner.

4. In the result, in the light of the submission of the learned counsel on either side, the application is disposed of permitting the applicants to make a detailed representation to the 1st respondent highlighting their grievances within two months from today and directing the 1st respondent that if such a representation is received within two months from today, the same shall be considered and disposed of with a speaking order within a period of three months from the date of receipt of the representation. No orders as to costs.
