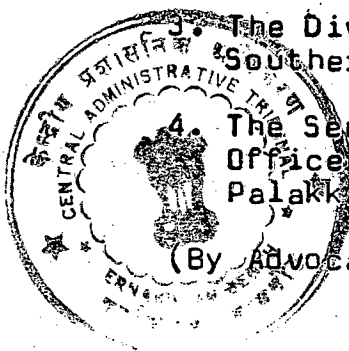

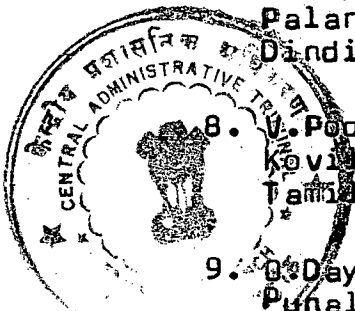

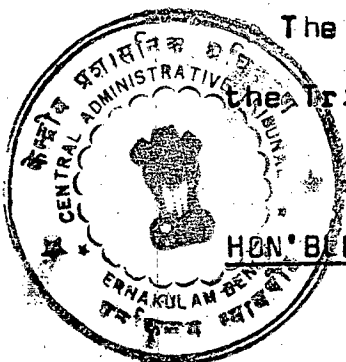

The applications having been heard on 29th October, 1997,
the Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR. P.V. VENKATAKRISHNAN, ADMINISTRATIVE MEMBER

When the matter came up for hearing today, learned
counsel for applicants submitted that the Railway Board
has since issued an order dated 21.8.97 in which detailed



instructions have been issued on how the Supreme Court's Judgement in RK Sabharwal Vs. State of Punjab (AIR 1995 SC 1371), Union of India and others Vs. Virpal Singh Chauhan and others (AIR 1996 SC 442) and J.C. Malik Vs. Union of India, 1978(1)SLR 844 are to be implemented. The grievance of the applicants will be crystallised after the implementation of these instructions and applicants will have to frame their grievances in an appropriate manner after the implementation of this order.

2. We, therefore, direct the respondent Railways to carry out the instructions in the circular of the Railway Board referred to above and draw the roster as directed therein within a period of three months and prepare a provisional seniority list on the basis of the revised roster. Applicants will thereafter be given adequate opportunity to represent if so advised against the provisional list drawn up in terms of the directions above. Respondent Railways will thereafter finalise the revised seniority list and communicate it to the applicants. Till this exercise is carried out the interim order already in force will continue.

3. If the applicants are aggrieved thereafter, they are at liberty to approach the appropriate authorities or judicial forum for their relief.

4. Application is disposed of as aforesaid. No costs.
