The application having been heard on 5-1-1998,  
the Tribunal on the same day delivered the  
following:

O R D E R

HON'BLE MR. A.M. SIVADAS, JUDICIAL MEMBER.

The applicant seeks for a declaration that she is entitled to be considered for selection and appointment as Extra Departmental Branch Post Master, Mannam Nagar Post Office and for a direction to the respondent to consider her for selection and appointment as Extra Departmental Branch Post Master, Mannam Nagar Post Office, though her name is not sponsored by the Employment Exchange.

2. The applicant is a degree holder in Arts and has registered her name with the Employment Exchange, Pathanamthitta. Since she came to know that there is a vacancy to the post of Extra Departmental Branch Post Master, Mannam

Nagar Post Office, she submitted a representation, A-1 dated 8-12-1997 to the respondent. She apprehends that due to the reason that her candidature is not sponsored by the Employment Exchange the respondent will not consider her candidature in the selection which will be held on 13-1-1998.

3. In the light of the decision of the Apex Court in Excise Superintendent, Malkapatanam Vs. KBN Visweshwara Rao, 1996 (6) SCC 216, it is not necessary that the candidate should have been sponsored by the Employment Exchange.



Accordingly, the respondent is directed to consider the candidature of the applicant also along with other candidates, if she is otherwise qualified, for the post of Extra Departmental Branch Post Master, Mannam Nagar Post Office in the selection to be held on 13-1-1998 or on any future date which it is postponed, in spite of the fact that her name is not sponsored by the Employment Exchange.

5. The original application is disposed of as above. No costs.

6. Standing counsel for the respondent submits that he will forward a copy of the application and a copy of this order to the respondent for compliance. We record the submission.
