The application having been heard on 07.07.2010, the Tribunal on the same day delivered the following:

**ORDER**

**HON'BLE MR K. GEORGE JOSEPH, ADMINISTRATIVE MEMBER**

The issues involved in both these cases are identical, the same are disposed of by this common order.

2. When the cases were taken up for hearing today, it transpired that on account of retirement of two employees on 30.06.2010, two vacancies have arisen against which it may be possible to accommodate the applicants in O.As

No. 630/09 and No. 137/10, as per the letter dated 10.06.2010 from Assistant Personnel Officer-I, Southern Railway, Palaghat addressed to Chief Personnel Officer, Southern Railway, Madras. In view of the vacancies that have arisen, the respondents are directed to consider favorably the representations of the applicants in O.A. 630/09 and 137/10 as early as possible but not later than six weeks. Till such time the decision taken on their representations is communicated to them, the Interim Order against their transfer to Salem will continue.

3. With the above directions, these two O.As are disposed of. No order as to costs.
