
The application having been heard on 28.1.98 the
Tribunal on the same day delivered the following:

The applicant who has rendered service earlier as
Extra Departmental Branch Post Master, Cherthala South Post
Office and Kattoor Kalavoor Post Office on a provisional
basis, is an aspirant for selection and appointment to the
post of Extra Departmental Packer, Pathirappally Post Office




and Kuthiathode Post Office. Her grievance is that by order dated 5.6.97(A-3), the applicant was told that she would not be considered for selection unless her name is not sponsored by the Employment Exchange and that therefore the respondent cannot consider her candidature for selection to this post. Therefore the applicant has filed this application for a declaration that though her name may not be sponsored by the Employment Exchange, she is eligible to be considered for selection and appointment to the post.

2. When the application came up for hearing, learned counsel for respondent states that in view of the ruling of the Hon'ble Supreme Court in Excise Superintendent, Malkapatnam, Krishna District, A.P. Vs KBN Visweshwara Rao, (1996) 6 SCC, 216, the respondent would consider the candidature of applicant also though her name had not been sponsored by the Employment Exchange.

3. In view of the above submission made by the learned counsel for respondent, we dispose of this application with to the respondent a direction to consider the candidature of the applicant also valid for selection and appointment to the post of Extra Departmental Packer, Pathirappally Post Office and

Kuthiathode Post Office though her name had not been sponsored by the Employment Exchange.
