The application having been heard on 17.12.2003, the Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR.A.V.HARIDASAN, VICE CHAIRMAN

The issue involved in all these applications is one and the same and the common order dated 4.11.96(A-1) issued by the Comptroller and Auditor General of India stating that no Section Officers Grade Examination <sup>would</sup> be held for the time being is under challenge in all these cases.

2. The applicants are employees under the Comptroller and Auditor General of India and their common grievance is that on account of the order impugned they are deprived of opportunities to pass the departmental examination which confer on them the benefit of their right to be considered for promotion and for other service benefits. Initially when the Original Applications came up for hearing, an interim order was issued directing the respondents to hold the examination provisionally. The matter was taken up by the respondents before the Hon'ble Supreme Court of India. The Hon'ble Supreme Court in Civil Appeal Nos.8476 to 8481 of 1997 dated 4th September 2003 held that, in view of the fact that there has been a backlog of 371 examination-qualified persons against a sanctioned strength of 230 SAO/AOs, the decision of the Comptroller and Auditor General of India cannot be held to be arbitrary or illegal, and the directions to hold the examination given by the Tribunal was not sustainable. Therefore, the Appeals were allowed.

3. In view of the fact that the question has been settled by the decision of the Apex Court, we dismiss all these Original Applications without any order as to costs.
