**ORDER**

**HON'BLE Dr. K.S.SUGATHAN, ADMINISTRATIVE MEMBER**

When the matter was taken up for hearing today, counsel for respondents produced a copy of order dated 13.08.2008 granting temporary status to 54 casual labourers. The list of 54 casual labourers includes 16 applicants of this OA, out of the total of 18 applicants. As per submission made by the counsel for the applicants, the applicant at Sl.No.3 in the list has passed away and the applicant at Sl.No.13 has not completed the required number of 260 days. All the remaining applicants, numbering 16, has been included in the list of 54 casual labourers who has been given temporary status.

2. In view of the aforesaid submission, counsel for applicant has no objection to treat this OA as having become infructuous. Accordingly, this OA is closed as having become infructuous. There shall be no order as to costs.
