**By Hon'ble Mr. Justice P.R. Raman, Judicial Member -**

All these are matters pertaining to the right of the applicants to participate in the departmental examination and also if passed, for getting further promotion. By an interim order they were enabled to appear in the departmental examination. Now the learned counsel appearing for the applicants seek withdrawal of the above OAs. We notice that pursuant to the interim order, all the applicants have appeared in the examination. Since the entitlement of the applicants to appear in the examination itself is in dispute and which was not decided at the time of passing the interim order,

we make it clear that the question is left open and the mere fact that they appeared for the test will not place them in a better position until the claim is decided in an appropriate proceedings. Accordingly, these OAs are dismissed as withdrawn, subject to the above.
