
ORDER

CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN:


Applicants seek a declaration that they are entitled to receive 'relief' on family pension. A consequential direction to respondents to pay the same is also sought. By judgment in Civil Appeal No.3543/90 and connected cases, a similar prayer has been declined by the Supreme Court. But counsel for applicants submits that a review application is being filed.

2. Following the decision of Supreme Court, we dismiss the application. Applicants may seek review in the event of Supreme Court reviewing the judgment in C.A. No.3543/90 and connected cases. No costs.
