AV HARIDASAN, VICE CHAIRMAN

The applicant who is working provisionally as an  
Extra Departmental Mail Carrier, is aggrieved by the decision  
of the Sub Divisional Inspector of Post Offices, Tripunithura

Sub Division that his representation for consideration for regular appointment to the post of Extra Departmental Mail Carrier would not be acceded to, as the Employment Exchange has not sponsored his name. The applicant has therefore filed this application for a declaration that he is entitled to be considered for appointment on regular basis as an Extra Departmental Mail Carrier and for a direction to respondents to consider him also at the interview scheduled to be held on 5.2.97.

2. Heard the learned counsel on either side. In view of the decision of the Supreme Court in Excise Superintendent Malakapatanam V KBN Visweshwara Rao and others, (1996) 6 SCC 216, the respondents have to consider the case of applicant also though not sponsored by the Employment Exchange, as the applicant is a working Extra Departmental Agent though provisionally and holds a current registration at the Employment Exchange. Therefore the case is admitted and disposed of with a direction to respondents to consider applicant also for regular appointment to the post of Extra Departmental Mail Carrier, Vettickal along with those who are sponsored by the Employment Exchange, even though the applicant's name is not sponsored by the Employment Exchange. No costs.
