The matter has come up before the Bench as the
respondents have not filed their reply statement so far.

2. The applicant has filed this application for
the following reliefs:

(i) to declare that the non-filling up of the
existing vacancies of Machinist (SK) on the
basis of Annexure.A4 recruitment rules as
illegal;

(ii) to declare that the non consideration of
theapplicant to the existing vacancies of
Machinist (SK) as illegal;

(iii) to direct the respondents to fill up the existing vacancies of Machinist (SK) in accordance with Annexure.A.4 Recruitment Rules duly considering the applicant; and

(iv) to grant such other further reliefs that this Hon'ble Tribunal may deem fit and proper.

3. Learned counsel for the applicant states that by Order No.CS 2764 53 dated 20th May, 1999 the applicant has already been appointed as Machinist (SK) under the respondents, that he joined the post and that therefore, the reliefs having been extended to him by the respondents themselves, it is not necessary to proceed with the matter further.

4. Noting the above submission, the application is closed without going into the merits of the case. Parties will bear their own costs.
