ORDER

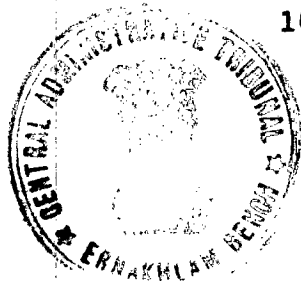
CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN

Applicants in all these cases, seek a declaration that they are entitled to a 'paid weekly holiday.' They further seek to restrain respondents from recovering amounts already paid to them, as Holiday Wages.

2. Admittedly, applicants are part-time casual employees. Some of the casual employees are given a paid weekly holiday, after six continuous working days. Respondents take the view that this benefit is available only to full time casual employees, and not to part-time casual employees.

3. Whether among casual employees, expressions like full-time and part-time have any legal significance is a matter of doubt. Counsel for applicants relied on AI in O.A.2333/93, to lace their contention that there is no distinction between the part-time and full-time casual employees. AI, letter of Department of Personnel dated 10.2.88 (No.45/95/87-SPB.I) inter alia reads:-

"(ii) The word "casual labourers" would cover full-time casual labour, part-time casual labour



and workers engaged on contingency basis. Part-time workers, casual or contingency paid, will be paid on pro rata basis. For the purpose of payment, no distinction should be made whether the casual labourers and contingency-paid staff are being paid wages or from office contingencies."

4. We do not think that we need pronounce on this question at least in the first instance. In the context of the present case, the Government of India should decide whether a distinction should or should not be made, between full-time and part-time casual labourers for purposes of paid weekly holidays. Applicants or their representative bodies may make representations before the Government of India and the Government of India shall take a decision thereon within four months of the date of receipt of representations.

5. As for amounts already paid, there can be no justification for recovery. As rightly pointed out by the Senior Panel Counsel Shri Kochunni Nair, payment appears to have been made without any conditions attached. In such circumstances even estoppel may stand against the respondents, from recovering the amounts. In Dr. P. J. Cooley Vs. Director, CIFT and others, (1991) 16 ATC 839, this Tribunal restrained the employer from recovering amounts paid, unconditionally. Following the decision and in the circumstances aforementioned, we restrain respondents from recovering the amounts already paid to applicants herein, by way of Holiday Wages.

6. With these directions, we dispose of the applications. Parties will suffer their costs.
