The application having been heard on 6.3.2003, the Tribunal on the same day delivered the following :

ORDER

HON'BLE SHRI A.V. HARIDASAN, VICE CHAIRMAN

The applicant, who is provisionally working as GDS Mail Packer, Thadiyoor applied for regular selection is aggrieved by non-consideration of his claim by the respondents for selection to the post of GDS Mail Packer, Thadiyoor. He also claims that he is entitled for regularisation. Therefore, he filed this application for the following reliefs :-

- (i) Declare that the applicant is entitled to be considered for the post of GDS Mail Packer/MC.

(ii) Direct the respondents to regularise the appointment of the applicant as GDS Mail Packer/MS - Thadiyoor.

(iii) Direct the respondents to consider Annexure A4 application submitted by the applicant and to appoint him to the said post.


(iv) To issue such other appropriate orders or directions this Hon'ble Tribunal may deem fit, just and proper in the circumstances of the case and

(v) to grant cost of this litigation.


2. When the matter came up for hearing on admission, Shri C. Rajendran, SCGSC took notice on behalf of respondents. The learned counsel of the applicant states that the applicant would be satisfied if the candidature of the applicant is also considered for selection along with others. The learned counsel for the respondents has no objection to such a direction.

3. In the light of the above submissions of the counsel on either side, the application is disposed of directing the respondents to consider the candidature of the applicant also along with others for selection to the post of GDS Mail Packer, Thadiyoor scheduled to be held on 7.3.2003. No costs.
