These applications having been heard together on January 17, 2014, the Tribunal delivered the following common order on March 6, 2014:-

## ORDER

Hon'ble Mr. Justice A.K.Basheer, Member (J)

Applicants in this bunch of 94 Original Applications are residents of various Islands in the Union Territory of Lakshadweep. Admittedly, all the applicants have been working on casual/daily wage basis in various departments under the Administration. All of them were engaged on casual basis for 89 days and re-engaged after a technical break of one or two days. This process has been going on in the case of quite a number of them for the last 10 to 20 years while in the case of a large number of others, such engagements are for 5 to 10 years and others are for two/three years or less. But in majority of the cases (in 80 Original Applications), these casual employees were engaged/disengaged by Village/Dweep Panchayats and/or District Panchayats. For the sake of convenience, these cases are categorized as “Panchayath and Non-Panchayath”.

2. The common grievance of all the applicants is that their services are not being regularized even though they have been working for years together, albeit on casual/daily wage basis. Therefore the common prayer in all these cases is for

Issue of a direction to the respondents to regularize their services. In the case of a few others who have been retrenched on completion of the period of engagement, the prayer is for issue a direction to re-engage them.



3. The short question that arises for consideration in all these Original Applications is whether the applicants are entitled to get their services regularized.

4. It has been noticed already that in majority of the cases, the applicants have been engaged to work in various departments under the Village/Dweep Panchayats and or/District Panchayats. Therefore, the Administration has taken a preliminary objection that this Tribunal has no jurisdiction to entertain those cases in view of the judgment rendered by a Division Bench of the Kerala High Court in *Administrator and another Vs. Naderkoya and others* – 2005 KHC 248. It is further contended by the learned counsel for the Administration in these cases that going by the dictum laid down in a catena of decisions of the Apex Court as well as that of various High Courts, the services of the applicants are not liable to be regularized since they were admittedly engaged on casual/daily wage basis for 89 days, though, of course, many of them were re-engaged after a technical break of one or two days.

5. In the other batch of cases in which the applicants have been engaged by the Administration in various departments under it, the contention raised by the respondents is that their engagement being of casual nature, they are also not entitled to get their services regularized. The common contention in all these cases is that these casual engagements were made without holding any regular selection process and that such engagements were not against sanctioned posts.

6. In this context, the learned counsel for the Administration has invited our attention to the following decisions in support of the above contention:-



7. In the above cases, the applicants have been admittedly engaged by the Administration in various Departments like the Department of Science & Technology, Industries, Environment & Forests, Electricity, Directorate of Labour & Employment, Directorate of Arts & Culture, Weights & Measures etc. While 7 applicants in OA 299/2013 and 47 applicants in OA 301/2013 have been working in the Department of Agriculture for the last 17 years right from January 1997, 2 of the applicants in OA 225/2013 have been working for 18 years whereas others in the above OA for the last 9 years. Similarly the applicants in OA 347/2013 have also been working ever since 1997. We have referred to the above 2 or 3 cases only to illustrate that majority of the applicants in all the cases - whether in the category of Panchayat or Non-Panchayat - have been working as casual employees for more than 10 years and quite a number of them have 8 to 10 years of service to their credit, if not more.

8. It is beyond controversy that all the applicants were engaged on casual basis without undergoing any regular selection process though in some cases the applicants have vaguely contended that such a process was

in fact undergone. However, in those cases also, no material has been placed before us in support of the above contention. Similarly it is not in dispute that such engagements were not made against sanctioned posts. In short this process of casual engagement on daily wage basis for 89 days



has been going on in the Union Territory for the last two decades or more. These employees have continued in such casual service with a technical break of one or two days for several years as a matter of routine. Apparently it is a case of Hobson's choice for them. It is on record that a large number of such casual employees had approached this Tribunal in the '90s seeking regularization or absorption. We have been informed that some of them were in fact absorbed. But the applicants before us in this bunch of 94 cases have apparently been less fortunate.

9. Umadevi (Supra) is a landmark judgment on the subject of "irregular" or "illegal" appointments in public employment. The five judge Bench had dealt with issues relating to absorption, regularization, permanent continuance of temporary/contractual/casual/daily-wage or adhoc employees appointed/recruited and continued for long in public employment dehors the constitutional scheme of public employment. The Apex Court exhorted all the High Courts not to issue directions for absorption or regularization unless the recruitment itself was, made regularly or in terms of the constitutional scheme. While issuing the above direction, their Lordships reiterated that it must be insisted that the States must make only regular recruitments and appointments. It was further observed that it would be erroneous to merely consider equity for a handful of people who have approached the Court with a claim, while ignoring equity for the teeming millions seeking employment and fair opportunity to compete for employment. While dealing with irregular appointments as distinguished from illegal appointments of duly qualified persons against duly sanctioned vacant posts, the Apex Court, after referring to those employees who have continued to work for 10 years or more but without the intervention of the orders of the Court/Tribunals, directed that the question of regularization of the services of such irregularly appointed employees be considered on merit in the light of the principles settled by the Apex Court in the cases in *S.V.Narayanappa - AIR 1967 SC 1071*; *R.N.Nanjundappa - (1972) 1 SCC 409* & *B.N.Nagarajan - (1979) 4 SCC 507* - as a one time measure.




10. A three judge Bench of the Apex Court in *Official Liquidator Vs. Dayanand & others* had, after noticing some of the judgments/orders of the court which took a different view from the law settled in *Umadevi*, observed that those cases were illustrative of the non-adherence to the rule of judicial discipline which is *sine qua non* for sustaining the system.

11. In *Harminder Kaur* – (2010) 1 SCC (L&S) 202, the Apex Court had held thus:-

*" Long service by itself may not be a ground for directing regularization. Regularization is not a mode of appointment. When appointments in public office are required to be made, provisions of Articles 14 & 16 of the Constitution of India are required to be scrupulously followed. When a departure is made for not scrupulously following the conditions precedent laid down in the statutory rules, as also the constitutional scheme, it is imperative that the same must be done within the four corners of the delegated power by the authority concerned."*

12. In the above case (*Harminder Kaur*), the appellants were school teachers and they were appointed by the Education Department of Chandigarh on contract basis for a specified period. In the offer of appointment itself it was made clear that the appointees would not have any claim for ad-hoc/regular appointments available in the Institute and that the contractual appointment could be made only against sanctioned post. The Apex Court while concurring with the view taken by the High Court held that initial appointments of the appellants were made in gross violation of the provisions contained in the relevant Act and also the doctrine of equality enshrined under Articles 14 & 16. However, taking note of the admitted position that 800 posts of teachers were lying vacant, the Apex Court expressed the hope that the plight of the appellants would also be taken into account by the administration and consider the desirability of relaxing the age-limit provided in the Rules.




13. In Nanjundappa (Supra), the Apex Court had held thus:-

*"If the appointment itself is in infraction of the rules or if it is in violation of the provisions of the Constitution, illegality cannot be regularized. Ratification or regularization is possible of an act which is within the power and province of the authority, but there has been some non-compliance with procedure or manner which does not go to the root of the appointment. Regularization cannot be said to be a mode of recruitment. To accede to such a proposition would be to introduce a new head of appointment in defiance of rules or it may have the effect of setting at naught the rules."*

14. We do not propose to burden this order by referring to several other decisions rendered by the Apex Court following the principles laid down by the five judge Bench of the Apex Court in Umadevi (Supra).

15. But one disturbing feature that has been noticed in this bunch of cases is that the authorities concerned, be it the Lakshadweep Administration or the Village (Dweep) Panchayats/District Panchayats, have not shown any anxiety about the sad plight of many of the employees who have continued in service for one or two decades or slightly less. It is also not clear whether any attempt was ever made to regularize the services of those irregularly appointed employees who had completed 10 years of service as indicated in Para 53 of the judgment in Umadevi (Supra) at that point of time.

16. Be that as it may, the fact remains that hundreds of employees in this bunch of Original Applications have admittedly been working for a decade or more with routine technical break of one or two days on completion of 89 days. It is true that the Administration or Panchayats may not require the services of quite a number of those employees throughout the year; but still it appears that many of them have been allowed to continue. Many of them have been engaged in one scheme or the other sponsored by the Central Government or in some such other schemes or programmes floated by the Administration on its own by utilizing the funds available with it. The Administration or Village (Dweep) Panchayats have not come out with




any data as regards the actual requirement of employees in various departments under them. It has been noticed that in some of the departments, the casual employees have been working apparently against regular posts for years together. Why is it that such posts are not identified and sanctioned ? There is no clue.

17. Learned counsel for the respondents has submitted before us that the policy of the Administration is to give minimum employment to maximum number of jobless people at least for a few days in a year by engaging them in one scheme or the other. The policy is laudable. But still, the question is why large number of employees working on certain posts for years together without any prospect of being regularized or absorbed, are being kept on tenterhooks like this ? The very fact that these people have been allowed to continue on those posts for years together will show that such posts are not of casual nature. We do not propose to deal with the above aspect any further at this stage though it may be observed that the attitude of the Administration and the local Panchayats appears to be totally uncharitable, to say the least.

#### Panchayath Cases

18. In the other bunch of 80 Original Applications, in which the applicants have been engaged by Village (Dweep) Panchayats or District Panchayat, the main contention raised by the learned counsel for the Administration is that this Tribunal has no jurisdiction to entertain these cases in view of the decision rendered by a Division Bench of the Kerala High Court in Naderkoya (Supra).

19. In the above case, some casual labourers working in the Water Supply Scheme of the Village (Dweep) Panchayat of Agathi Island had approached this Tribunal, aggrieved by the failure of the Union of India and the Lakshadweep Administration in granting them temporary status under the Scheme for Temporary Status & Regularization introduced by the Union of India, in O.M.No. 51016/86/Estdt (C) dated 10.09.1993. It appears that the upkeep, maintenance and distribution of the drinking water



to the local residents of Agathi Island were initially undertaken by the Public Works Department. Later, it was entrusted to AVAM Society. Grant-in-Aid was provided to meet the additional expenditure and the Society used to manage the Scheme. Later, Island Councils were brought into existence as per Island Council Act. Still later, the Councils were abolished as the Lakshadweep Island Regulation, 1988 was repealed by Section 88 of the Lakshadweep Panchayat Regulation, 1994 and during the year 1995 all the assets and liabilities of the Island Council of Agathi were transferred to Village/Dweep Panchayat of Agathi. Thus all the labourers working with the Water Supply Scheme came under the Village (Dweep) Panchayat. The casual labourers who had approached this Tribunal were admittedly under the services of the Dweep Panchayat and they were being paid by the Panchayat from the fund available with it. After considering the claim of the casual labourers, the Tribunal issued the following among other directions:-

- a) *The Second respondent i.e. the Lakshadweep Administration would adopt the Department of Personnel & Training Casual Labourer (Grant of Temporary Status & Regularization) Scheme, 1998 and prescribe it prospectively to the Panchayats for granting temporary status to casual labourers as per the parameters of the scheme.*
- b) *The first respondent, i.e. the Union of India in the Ministry of Personnel, Public Grievances and Pension would ensure that appropriate legal and technical formalities are completed and the Scheme is made applicable expeditiously.*
- c) *From the date of issue of these orders and until the Lakshadweep Administration prescribes the scheme to the Panchayats for regularization of eligible casual workers, no regular appointments would be made by the Panchayats in respect of at least two third of the regular vacancies in Group D which would be kept reserved for the regularization of the casual workers under the scheme.*
- (d) *No casual workers, including the applicants, who are in the service of the Panchayats on the date of issue of these orders would be retrenched on the face of availability of work or for making way for fresh recruits without considering them for the grant of temporary status if eligible as per the scheme.*

The Division Bench of the High Court while allowing the Writ Petition filed by the Administration noticed that another Bench of this



Tribunal in Original Applications No.1297 & 218 of 1998 had rejected an identical relief claimed by some other casual labourers, holding thus:-

*"We have carefully perused the pleadings and other materials on record. We have also given our anxious consideration to the rival submissions. We find that in both these O.As under consideration, the applicants were engaged by the Island Council of Androth/Minicoy. They might have continued to be engaged subsequently by the succeeding local self Government body, namely the Village (Dweep) Panchayat of Androth/Minicoy. The Chairpersons of the respective Island Council might have with or without proper authority from the Councils issued what are purported to be appointment orders and the subsequent service certificates. We have good reason to reject the same as those do not reveal the applicants' nexus with the Administration of U.T. of Lakshadweep in order that they might have a cause of action before us. The applicants have not adduced any evidence to show that they were appointed against any posts sanctioned or approved by the Lakshadweep Administration....."*

*In the case on hand the applicants were not employed against any posts sanctioned by the administration and that would make all the difference. The Island Council or the Chairpersons, as the case may be, for reasons best known to them, seem to have accommodated these people. They might rightly come under the wage employment programme as a poverty alleviation measure under the DRDA or they might have been employed since the Village (Dweep) Panchayat authorities considered it expedient to give employment to them. It probably might have offered some succor by way of daily rated wages to the unemployed local persons....."*

*Neither the Panchayat authorities (respondents 4 and 5) nor the applicants have shown how the posts created/retained in addition to those sanctioned by the Administration could be considered regular. As matters stand, the Administration of U.T. of Lkshadweep has no accountability as far as the matter of regularization of the applicants are concerned. The anxiety of the U.T. Administration to prevent misapplication of funds granted to the Village/District Panchayat for developmental purposes towards expenditure on account of wanton appointments of staff against posts neither created nor sanctioned nor approved is legitimate."*


21. The above decision was confirmed by a Division Bench of the High Court in O.P.No.28776/2001. Still later, OA No.1008/1997 and OA No.571/1998 were also dismissed by a common order following the decision mentioned supra. This order was also confirmed by the High Court in O.P.No,35164/2001.

22. After referring to the above orders, the Division Bench of the High Court in Naderkoya (Supra) held that Lakshadweep Administration did not have jurisdiction to frame scheme for absorption of casual employees in the service of the Panchayat. It was further observed that the question of absorption was a matter which the Panchayat has to consider taking into account its financial status and various other administrative policies. The following are the observations of the Division Bench:-

*"In view of the above mentioned circumstances, we have no hesitation to hold that the Tribunal has committed a grave error in giving direction to Lakshadweep Administration to adopt the Department of Personnel & Training Casual Labour (Grant of Temporary Status & Regularization) Scheme 1993 and prescribe it prospectively to the Panchayats for granting temporary status to casual labourers. The direction given to the Panchayat not to effect any appointments till the Lakshadweep Administration frames Scheme, is illegal and do not fall within the jurisdiction of the Tribunal. Further direction given to the Panchayat that no casual workers would be retrenched on the face of availability of work falls within the domain of the Administration. In such circumstances, the order passed by the Tribunal in OA 820 of 2001 stands set aside."*

23. In this context, it is pertinent to note that in many of the cases, the Chairpersons of the Panchayats have issued orders of appointment of casual labourers. It is fairly conceded by the learned counsel for the applicants that such orders could have been issued only by the Executive Officer of the concerned Panchayat. Strangely, in some of the cases, the Panchayats are represented by their Chairpersons and not by the Executive Officers.


24. There is yet another aspect of the matter. In the course of hearing of the cases, it was submitted by learned counsel for the applicants in some cases that different political parties are in power in various Panchayats. Equations of power have changed after the last Panchayat elections. Some of the orders of appointments were cancelled by the successor Committee in office of these Panchayats. More importantly, fresh engagements are being made on political basis and some of the disengagements/retrenchments also have political colours.



25. In OA 300/2013, the Chairperson of Village (Dweep) Panchayat of Androth Island has appeared through Advocate R.K.Muraleedharan, and contended in the written statement, inter-alia, that termination of services of the applicants in the above case is exclusively within the jurisdiction of the Panchayat especially after issuance of Annexure R4(b) notification dated March 7, 2012 issued by the Administration of the Union Territory of Lakshadweep. It is pointed out by the learned counsel that by virtue of Annexure R4(b) notification issued in terms of Articles 243(g) of the Constitution, the Panchayats are vested with powers and authority to function as institutions of local self governance. The learned counsel has invited our attention to various clauses contained in the above notification in support of the argument that the Panchayats are vested with the right and authority to "hire and fire" employees. However, it is conceded that the Village (Dweep) Panchayats have no power to regularize the services of the applicants though the Panchayats are in dire need of the services of the applicants who are having sufficient experience. It is further conceded by respondent No.4 in the above case that the Panchayats are not vested with the power to create any post without prior approval of the Administration.

26. Strangely, in most of the cases relating to employees engaged by the Panchayats, the Standing Counsel for the Administration himself has appeared for the Panchayats as well.

27. Learned counsel for the applicants in some of the cases have invited our attention to various provisions contained in the Lakshadweep Panchayat Regulations, 1994 and the allied rules thereunder. While inviting our attention to Lakshadweep Panchayat (Grant-in-Aid) Rules, 1997, Sri P.V.Mohan who appears for the applicants in some of the cases, contends that once the Administration sanctions 'Grant-in-Aid', it is for the Panchayat to execute the various works like road construction/repair/maintenance, water supply, drainage, local



development works, primary education, health and sanitary scheme etc. For this purpose, the Panchayats can engage workers and therefore necessarily the Panchayats have the power to regularize or absorb casual workers, especially after the introduction of the Lakshadweep Panchayats Regulations, 1994. The learned counsel has invited our attention to Article 234(g) and Article 40 of the Constitution of India in this context. We do not propose to refer to or deal with identical arguments advanced by other learned counsel as well, since it has already been noticed that going by the decision in Naderkoya (Supra), this Tribunal has no jurisdiction to entertain this bunch of Original Applications relating to employees who were engaged by the Panchayats.

28. Sri N.Unnikrishnan who appears for the applicants in OA 394/2013 has raised a further contention that the casual labourers who have been working for more than 240 days in a calender year are entitled for protection under Chapter V (a) of the Industrial Disputes Act and that their services cannot be dispensed with arbitrarily. It is further contended that one set of casual employees cannot be replaced by another set of casual employees as held in *State of Haryana Vs. Piara Singh - (1992) 4 SCC 118*. The learned counsel points out that some of the applicants in OA 394/2013 have been working since 1994 while others have put in more than 4 years of service.

29. The sum and substance of the arguments advanced by the learned counsel for the applicants in all these cases is that they may be allowed to continue in service, albeit on casual basis. It is true that the applicants in all these cases, whether in the category of Panchayat or non-Panchayat, have been working on casual basis for a large number of years. It has been noticed already that some of the applicants have been working since 1994 and many of them since 1997. Quite a few of them have been working for periods ranging between 5 to 10 years. There are only very few who have been working for 2-3 years or less. Most of them are still continuing on the basis of interim orders passed in these cases.



30. When these cases had come up for consideration before a Single Bench (Judicial Member) on 3.7.2013, the following order was passed:-


9. Perusal of the applications reflects that save that in all the cases, the period of engagement at one stretch is limited to 89 days and with an artificial break of one day, the cases are not identical in other aspects. In many, the period of engagement is for over two decades, in some, specific qualifications have been prescribed; in some other the work cannot be carried out by all as such jobs requires either training or specialization or training. Admittedly, a number of applicants have been functioning as casual labourers for decades by now. Most of them have been through regular selection though some of those had not initially registered their names with the authority concerned. Some of them have been functioning in veterinary units which require special skill; some function as drivers and the like. In many cases, the wages are fixed per month. Thus, the applicants do not constitute a homogeneous group but a heterogeneous cluster. Continuance of interim order or vacation of interim order for all without intelligible discrimination would not meet the ends of justice. Keeping in view (a) the rights that might have been crystallized by some (e.g. in respect of those who have been functioning for a long time without the intervention of the Court/Tribunal), (b) the qualifications prescribed in some cases, (c) the specialized nature of the job, which cannot be performed by all; (d) the consolidated amount payable to some instead of wages on per day basis under the Wages Act, (e) the fact that many of the applicants are functioning under certain scheme, continuance of the interim order has to be considered differently for different categories of applicants though till now, by a common order on 4<sup>th</sup> June, 2013 and thereafter the interim order has been passed.

10. For this purpose, all the serving casual labourers should be identified and grouped as under :-

(a) Those who have put in more than 10 years of casual labour service, with or without the artificial break. These may include those who have been inducted with specific qualification of matriculation/ITI and the like and also those who have been inducted under specific schemes

(b) Those who have been inducted with specific qualification of matriculation or other specialized course beyond Matriculation, such as ITI, or possessing specialized skills, such as date entry operator, drivers etc. which job cannot be accomplished by ordinary casual labour normally engaged for manual works. This list may include those who have been engaged under some project or scheme, but not coming under (a) above, i.e. with less than ten years of service.

(c) Those who have been engaged under one scheme or the other (other than those who have been engaged under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS for short), but not those who come within (a) or (b) above.



- (d) Those who come under the MGNRGS scheme
- (e) Those who are mere casual labourers not falling under any of the above.

11. Of the above, disengagement of the existing casual labourers and replacement by others in the waiting list, should be first in respect of (e) above. These casual labourers cannot claim any right to continue and they have to be rotated. And in their place, for 89 days, those in the waiting list (wardwise/Islandwise) may be engaged. This again, should be after giving them a notice of two weeks before disengagement. The purpose of giving two weeks notice is that if the casual labourers sought to be disengaged feel that they belong to category (a) or (b) above, they may make due representation and the same would be considered forthwith by the Administration and their decision communicated to such individuals.

12. Similarly, those coming under group (d) above, i.e. those who have been engaged under the MGNRGS could be disengaged as in their case the scheme itself was affording employment for a period of a minimum of 100 days, which would enable those who are still waiting to avail of the benefit of the scheme. Such of these casual labourers could be disengaged after they have been granted 100 days of work and hereagain, after giving them a notice of two weeks before disengagement.

13. In respect of (c), if the scheme under which the casual labourers have been engaged provides for certain conditions precedent for disengagement, it is subject to such a condition only their services could be disengaged. Rest of the casual labourers shall continue until further orders.

14. In respect of (b) and (a), their services as casual labourers shall not be disturbed until further orders. The disengaged casual labourer (as contended by the counsel for the applicant in OA No. 507 of 2013), if falls under (b) or (a) above, i.e. with more than ten years of service or with specific qualification such as matriculation or the like (here stated to be ITI), he shall be re-engaged before the next date of hearing and confirmation given on the next date of hearing."


31. Pursuant to the above order, the Panchayats/Departments have issued certain circulars which are marked as Annexure A5 to A8 in OA 300/2013. Apparently, some attempt has been made to categorize the labourers group-wise as delineated in the above interim order. Thereafter, several employees were sought to be disengaged. Understandably, all these employees who faced the threat of disengagement have approached this Tribunal and those Original Applications are also included in this bunch of cases. It appears that the Administration has also sought to rely on the



judgment of the Division Bench of the Kerala High Court in O.P.(CAT) No.133/2012 and No.606/2012, contending, inter-alia, that its policy is to give minimum employment to maximum people at least for a few days in a year. In this context the Administration has also referred to some of the schemes floated by the Union of India which ensures minimum 100 days' employment in a year to maximum number of people.

32. The short question that arises for our consideration is whether the applicants are entitled to get their services regularized or not. It has been noticed already that there is nothing on record to show that the applicants had been engaged against any sanctioned posts or that they were so engaged after undergoing regular selection process. In our view, the Administration has been largely responsible for the prevailing unfortunate scenario. It may be true that the Administration or Panchayats in their anxiety to give some solace to a large number of unemployed people might have engaged these applicants on casual basis. Undoubtedly, their services were required in various Departments or Works as otherwise many of the essential services would not have been in operation. Because of the peculiar geographical nature of the tiny islands and also the scarcity of job opportunities, the islanders are destined to face this rigmarole without any demur or protest. These people cannot aspire to get employment in the mainland also. The predicament of the islanders is understandable. However, going by the catena of decisions referred to above, it cannot be held that the applicants are entitled to get their services regularized. It has been repeatedly held by the Apex Court that there is no room for any sympathy for such casual labourers even if they have continued in service for a large number of years.

33. But, in our view, the Administration has to necessarily give adequate consideration to those employees who have been working on casual basis for more than a decade or two. Similarly, the plight of those employees who have been working on casual basis for the last 5 to 10 years is also equally pitiable. These employees, in our view, are entitled to get the



benefit of relaxation in age and other essential qualifications to the extent possible when fresh recruitments are being made. It shall be ensured by the Administration that the entire process of engagement of employees on casual basis (if it becomes extremely essential and unavoidable) is streamlined so as to avoid unnecessary legal complications in future. Appropriate guidelines/regulations can be formulated for engagement of casual employees in the projects (either seasonal or otherwise) that may be implemented in the island.

34. We refrain from issuing any other directions since, in our view, it falls within the domain of the Administration. However, the Administration shall address the issue relating to all these employees who have been toiling for years together on casual basis, with utmost compassion, and give them the benefit of relaxation in age, educational qualifications etc. while making regular recruitment.

35. Original Application Nos. 212, 266, 268, 299, 325, 347, 354, 366, 372, 380, 488, 499, 509 & 1225 of 2013 are disposed of with above directions.

36. As regards other Original Applications, where engagements were made by Panchayats, it is held that this Tribunal does not have jurisdiction to entertain them. It will be open to the applicants to approach appropriate judicial forum for redressal of their grievances. These Original Applications are, therefore, dismissed.

37. The interim orders in force as on today shall remain extended till April 4, 2014.
