ORDER

HON'BLE SHRI A.V. HARIDASAN, VICE CHAIRMAN

The applicant, who is performing the duties of G.D.S. Mail Carrier in Memala Post Office has filed this application challenging Annexure A5 order dated 1.4.2002 issued by the Inspector, Posts, Nedumangad, the 1st respondent to the Sub Postmaster, Vithura for making a stop gap arrangement terminating the services of the applicant and for a declaration that the applicant is entitled to continue as G.D.S. Mail Carrier, Memala till a regular selection is made.

2. Shri C. Rajendran, SCGSC on instructions from the respondents states that at present there is no intention to terminate the services of the applicant and to replace him with another person and the proposal is only for mechanising the mail root of G.D.S. M.C., Memala. Further, it is stated that the applicant's service would not be terminated to make another stop gap arrangement. Noting the above submission made by the counsel for the respondents, the application is disposed of without any further direction. No costs.
