
The applications having been heard on 25.8.96 the Tribunal on the same day delivered the following:

O R D E R

HON'BLE MR AV HARIDASAN, VICE CHAIRMAN

The facts and the question of law involved in all these cases are similar in character. Hence they were heard and disposed of by this common order.

2. The applicants in all these cases are persons who have rendered casual service under the Telecom Department of the Kerala Circle for various periods but now remaining disengaged. They have filed these applications for a declaration that they are entitled to get work and wages as casual mazdoors and for a direction to the respondents to engage the applicants for work subject to availability of work on the basis of their prior service. They have placed reliance on a ruling of this Tribunal in O.A.1402/93 rendered under similar circumstances.
3. The respondents resist their claim on various grounds including the ground of limitation. When the matters came up for hearing today, learned counsel on either side agreed that Special Leave has been granted against the order in O.A.1402/93 in SLP No.19036/93 and as the operation of the order of this Tribunal has been stayed, all these applications may be disposed of with a direction to the respondents in these cases that depending on the decision of the Hon'ble Supreme Court if the respondents are to prepare a list of casual



labourers, the claim of the individual applicants put forth in each of these applications shall be considered by the respondents and speaking orders given to them.

4. In the light of what is stated by the learned counsel, these applications are disposed of without entering into the merits of the cases with a direction to the respondents that if the respondents are to prepare a list of casual labourers consequent on the decision of the Tribunal in O.A.1402/93 as a result of the decision of the Supreme Court in the appeal against the judgement, the respondents shall consider the claims of the applicants in all these cases separately for re-engagement and shall give them a speaking order each. No costs.
