The application having been heard on 7.8.2002 the Tribunal on the same day delivered the following:


O R D E R

HON'BLE MR A.V.HARIDASAN, VICE CHAIRMAN

The applicant, an Assistant Accounts Officer, Department of Agriculture and Cooperation, Kochi, has filed this application challenging A-3 order by which he is relieved of his duties to give effect to his appointment as Pay and Accounts Officer in the Ministry of Urban Development and posting as Finance Officer, CPWD, Siliguri.


2. The respondents have filed a reply statement. On the basis of an interim order, the applicant is continuing in his present office. Now the learned counsel for respondents states that on a consideration of the averments made in the application, the competent authority would consider the request of the applicant seeking permission to decline promotion in accordance with rules if a representation is made within a week from today and that the application may be disposed of permitting the applicant to make the such representation and directing the 1st respondent to take a decision on his request and to communicate the same to him within a reasonable time, keeping the relief of the applicant pending. The above proposal is acceptable to the applicant also, who is present in person.

3. In the light of the above development, the application is disposed of permitting the applicant to make a representation to the 1st respondent seeking permission to decline promotion as PAO and posting as F.O. within a week from today and directing the 1st respondent to consider the



representation and to give the applicant an appropriate reply. We also direct that till a reply is served on the applicant on the aforesaid representation declining promotion, the applicant shall not be relieved from the present place of posting. There is no order as to costs.
