Applicant seeks the following reliefs:

- (i) To call for the files leading to Annexure A6 and quash A6.
- (ii) To declare that the applicant is entitled to be considered for appointment as E.D.Messenger, Aroor in preference and to the exclusion of outside candidates.
- (iii) To direct the 1st respondent to consider applicant for appointment as E.D.Messenger, Aroor Post Office in terms of A3 standing instructions and to go for an open market recruitment only if the applicant is not qualified for the said post.
- (iv) To grant such other relief which may be prayed for and which this Hon'ble Tribunal may deem fit and proper to grant in the facts and circumstances of the case.


