Applicant approached this Tribunal to declare that he was entitled to be appointed in Group 'D' with effect from 4.7.1992.



2. On 20.5.1991 when he was working as an Extra Departmental Agent, he was selected for appointment in Group 'D' and an offer of appointment was made by Annexure A-2 dated 3.6.1991. Applicant did not accept it for personal reasons, it is said. Thereafter, other events supervened. For obvious reasons, we do not refer to these. Applicant has since been promoted with effect from a date in 1995.

3. After arguing the matter in some detail, counsel for applicant sought permission to withdraw the application with freedom to move the department, with a request to prepone the date of promotion. Reserving freedom to do so, we grant leave and dismiss the application as withdrawn. No costs.
