Applicant seeks a direction to appoint him in  
a future vacancy arising under respondents in accordance  
with A-1. He had approached this Tribunal earlier with  
O.A. 1246/94 and we directed respondents to examine the

facts of the case and pass appropriate orders.

2 Respondents then passed A-4 order, inter alia stating:

"In the absence of details regarding his engagement the case could not be investigated further".


Eventually they came to the conclusion that applicant was not engaged as a casual mazdoor at any time. His identity was also not very clear to respondents.


