O R D E R

CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN

Applicants herein are casual employees working in the Passport Office, Kozhikode. They challenge an order dated 6.12.93 terminating their services.

2. After the matter was heard at some length, counsel appearing on both sides came out with an agreed formula. In view of that, we consider it

unnecessary to go into the merits or express any opinion on the merits. We record the agreed formula.

It is agreed that:

- (a) The work requirements of the Kozhikode, Cochin and Trivandrum Passport Offices under the Union of India will be assessed by the department and they will engage casual employees to the extent necessary.
- (b) A common Seniority List of casual employees working at Calicut, Cochin and Trivandrum Passport Offices will be prepared, ranking them in the order of their length of service/number of days of service put in by them as on 6.12.83 (which is the date of the impugned order). Casual employees will be engaged from this list and they will be engaged on the basis of the priority of their ranking in the list.
- (c) Though the Passport Office/Offices of Cochin and Trivandrum are not parties before us, counsel for Union of India representing these offices submits that Union of India is agreeable to maintain a common Seniority List and make appointments from this List, which will be prepared on the basis of the length of service/number of days put in by the casual employees as on 6.12.93, as already noticed.
- (d) Casual employees working in the same category will be paid the same daily rate of wages (example, all Clerks will get the same wages, and all Peons will get same wages).



3. We record the submissions and direct the parties to abide by the agreement. We make it clear once again that we have not expressed any opinion on the merits.

4. Applications are disposed of as aforesaid. Parties will suffer their costs.

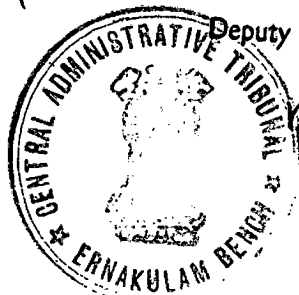
