Applicants were earlier working as daily rated Casual Workers in the Passport Office, Trivandrum. They were retrenched from service. Subsequently they appeared for an examination conducted on behalf of the respondents by the Staff Selection Commission and they have all qualified. Learned counsel for applicants submits that some of them have been reengaged and that others may also be reengaged. He also submits that the applicants may be regularised.


2. Respondents in their reply have stated that those who have qualified would be absorbed as regular staff and that till absorption they will continue to be casual employees.

3. In the light of this submission, we see no need to pass any orders in this application. Respondents will consider the cases of applicants for reengagement/regularisation in their turn and pass appropriate orders.
