Applicant a casual labourer who is presently  
working as leave substitute of regular Extra Departmental  
Messenger of R.E.C. Post Office, Calicut is aggrieved  
because the respondent is not considering his name for  
regular appointment to the post of Extra Departmental  
Stamp Vendor at Mukkom Post Office for the sole reason  
that his name has not been sponsored by the Employment  
Exchange. The applicant holds a current registration  
with the Employment Exchange, Calicut. Therefore he has  
filed this application for a declaration that he is entitled  
to be considered for appointment as Extra Departmental




Stamp Vendor, Mukkom Post Office.

2. Shri A.C.Devy representing Mr.Mathews J Nedumpara, Standing counsel appearing for respondent states that the respondent has no objection in disposing of the application with a direction to consider the case of the applicant in view of the ruling of the Hon'ble Supreme Court reported in (1996) 6 SCC 216.

In the light of the above submission of the learned counsel, we admit the application and dispose it of with a direction to the respondent to treat that the applicant is also eligible to be considered for regular selection though not sponsored by the Employment Exchange and to finalise the selection for appointment to the post of Extra Departmental Stamp Vendor, Mukkom Post Office considering the applicant also. There is no order as to costs.
