This Original Application having been heard on 17.11.2014, the Tribunal on the same day delivered the following:

ORDER

Applicants filed MA No. 180/1231/2014 stating that after filing of this OA applicant No. 18 who is working in LPSC, Valiamala has been granted the benefit of stepping up of pay as prayed for in the Original Application. When the other applicants raised the issue once again before the competent authorities highlighting the fact that the co-applicant has been granted the benefits as claimed in this OA, it was assured to them that the claims/representations of the other applicants also will be looked into. Therefore, applicants pray for permitting them to withdraw the OA with liberty to pursue the claim raised in the OA before the competent authorities among the respondents reserving the rights of the applicants to approach this Tribunal in case the grievances remain un-redressed.

2. Mr. Rajesh learned counsel representing Mr. Sunil Jacob Jose, learned SCGSC submitted that there is no objection for the respondents in allowing the aforesaid relief sought for in the MA. Hence, the MA stands allowed.

3. Therefore, the OA is allowed to be withdrawn granting liberty to the applicants 1 to 17 for approaching this Tribunal on appropriate cause of action, if so advised.
