The applicant, Primary Teacher, Kendriya Vidyalaya,
Pallipuram, Thiruvananthapuram is aggrieved that while the second
respondent issued order dated 31.3.03 (now produced by the
respondents with a memo) the third respondent has on the basis of
an alleged telephonic instruction modified the order relieving
the applicant by Annexure A2 order to report at Kendriya

Vidyalaya, Pallipuram, Thiruvananthapuram. The applicant has, therefore, filed this application seeking to set aside the order dated 31.3.2003, for a declaration that the applicant is entitled to be posted as Primary Teacher at Kendriya Vidyalaya, Cochin in terms of order dated 31.3.03 and for a direction to serve a copy of the order and to implement the same.

2. When the matter came up for hearing today, the learned counsel appearing on behalf of respondents stated that the order dated 31.3.03 posting the applicant to Kendriya Vidyalaya, Cochin shall be implemented within two weeks. Since the respondents agreed to implement Annexure A3 order, the fourth respondent is directed to relieve the applicant to give effect to the order dated 31.3.03, posting the applicant as Primary Teacher, Kendriya Vidyalaya No.1, Naval Base, Kochi within two weeks from today. No costs.
