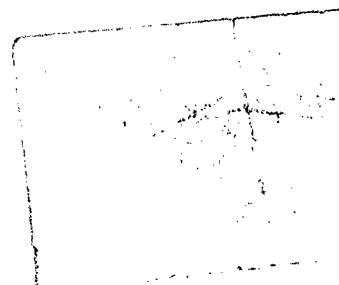

These applications having been heard on 20th July, 2006, the Tribunal on the same day delivered the following:-

(ORDER)

Hon'ble Shri N.Ramakrishnan, Administrative Member

The learned counsel for respondents referred to MA-663/2006 to which were attached Annexure A-10 and A-11 and he focused our attention to the operative portions contained in para 2 and 3 which is extracted below:-

- "2. The provision of the said Fast Track Promotion Scheme has since been reviewed. It has been decided to delete the said provision of Fast Track Promotion and to provide for filling up the posts by 100% promotion. Therefore, the Recruitment Rules of the posts in question have since been amended. A copy of the so amended Rules which are called Department of Posts {Posts & Telegraphs (Selection Grade Post)} Recruitment (Amendment) Rules 2006 notified in Gazette of India Extraordinary on 18/5/2006 is forwarded herewith for your information and future guidance.
3. It has been decided that the vacancies which are lying unfilled may be filled up as per the revised Recruitment Rules dated 18/5/2006."

2. Learned counsel for the applicants pleaded that in view of the long wait suffered by the applicants, use should be made of these

amended rules to give them the benefit of promotions expeditiously. The Learned Senior Central Government Standing Counsel agreed to issue of direction in these lines.

3. In these circumstances, we issue a direction that the respondents may take immediate steps and fill in the vacancies in terms of paragraph 3 of Annexure A-11 expeditiously.

4. With this direction, the OA is disposed of. No costs.
