O R D E R


CHETTUR SANKARAN NAIR(J), VICE CHAIRMAN

Applicant seeks a declaration that he is entitled to reckon seniority in the post of Peon, with effect from 22.4.1985. It is said that certain persons have been granted seniority over him, though in fact they are junior to him. Respondent Divisional Personnel Officer states in A6 that seniority was given to the others by reason of the orders of this Tribunal. If

applicant is aggrieved by the order of the Divisional Personnel Officer (A6) he may bring his grievances to the notice of the 24th respondent Chief Personnel Officer. If a representation is made, 24th respondent will consider the representation with notice to all officials who may be affected by a decision in the matter and pass a reasoned order within four months of the date of receipt of the representation and communicate the same to applicant. We may also point out that if applicant was not a party to O.A. 548/93 and O.A. 966/93, those orders cannot cause any adverse consequences to him.

2. Application is disposed of with the aforesaid directions. No costs.
