Applicant seeks to quash A-5 and A-7, to direct respondents to restore A-2 seniority list of Ernakulam Bench duly granting consequential benefits thereof and to publish the all India seniority list of Lower Division Clerks in the Central Administrative Tribunal within a time frame.

2. When the O.A. was taken up, counsel on both sides submitted that A-5 and A-7 may be quashed in the light of the ruling of the Apex Court in M Ramachandran Vs Govindh Ballabh & others, JT 1999(7)SC 271 and the respondents may be directed to finalise the seniority list of the Lower Division Clerks of the Ernakulam Bench.


