Applicants submit that they are entitled to
have their pay re-fixed in the revised scale of
Rs.1350-2200. They rely on the judgments Annexure
A1 and A2 and also Annexure A3 order, to support


their contentions. We find that applicants have made Annexures A4 to A10 representations and that the same are pending consideration before 4th respondent Controller. We direct the said respondent to consider Annexure A4 to Annexure A10 and pass appropriate orders after examining Annexures A1 to A3 within three months from today. If applicants are similar as the applicants in Annexures A1 and A2 we see no reason why a distinction should be made between the two groups.
