**ORDER (ORAL)**

Heard.


2. It is not disputed that applicants before me had already been accorded temporary status w.e.f. 20.11.1989. Their claim is that they had worked for almost 16 years, yet they are not regularized against group 'D' posts. It is averred in paragraph 2.2 of the OA that certain persons junior to them have been regularized against group 'D' posts by Chief Post Master General. The representations preferred by applicants to the Director General of Posts, which is an appropriate authority to sanction posts is yet to be responded to.

3. In the reply filed by respondents it is stated that applicants are CP Chowkidars and cause of action lies by way of representation to SSPO and as this has not been done it is stated that there is an assumption that no vacancy is available to accommodate them.

4. While perusing paragraph 4.2 of the reply the above plea of discrimination in the matter of regularization is not specifically rebutted by respondents.

5. It is trite law that once the averments are not rebutted specifically, are deemed to be admitted. However, regularization of a casual worker with temporary status depends on availability of vacancies in Group 'D' posts, which is the prerogative of Government to sanction posts.

6. In this view of the matter, taking cognizance of the fact that juniors who had been engaged later on and accorded temporary status much later to applicants have been regularized, the representations preferred by applicants to the Director General of Posts shall be considered by Respondent No.1 and a reasoned and speaking order be passed relating to the grievance of applicants and their claim for regularization, within a period of two months from the date of receipt of a copy of this order.
