Heard both sides.

2. The applicants have filed original application to issue direction to respondent No. 1 to take a final decision with regard to extension of pay scale of Rs. 6500-10500/- to them w.e.f. 15.9.2006 with all consequential benefits with in a specified time. It is also the contention of the applicants that they made representation covered under Annexure A-9 dated 2.11.2006 seeking the relief as prayed in the original application and also reminder covered under Annexure A-1 dated 18.5.2007 and the respondents have also acknowledge their representations in their letter Annexure A-10 dated 5.10.2007 and replied that the matter is under consideration for disposal.

3. In view of the above circumstances, without disposal of pending representation of the applicants, passing ~~of~~<sup>2</sup> any order or issuing directions to the respondent authorities allowing the claim of the applicants is not at all justified at this stage. In the interest of justice, O.A. is disposed of with a direction to the respondents /competent authority to dispose of the pending representation of the applications covered under Annexure A-9 dated 2.11.2006 and reminder covered under Annexure -1 dated 18.5.2007, ~~and~~<sup>2</sup> taking note of their letter Annexure -10 and pass a reasoned order as per rules within a period of 2 months from the date of receipt of copy of this order No costs.
