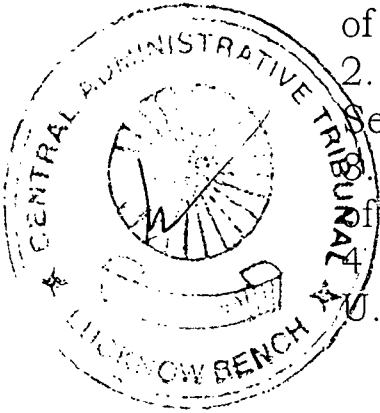

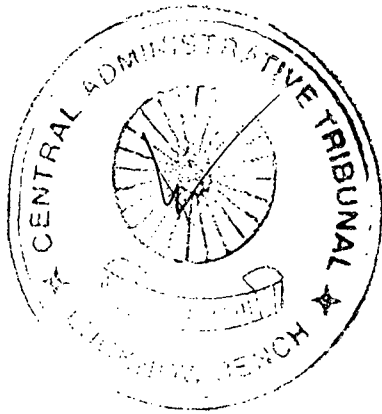

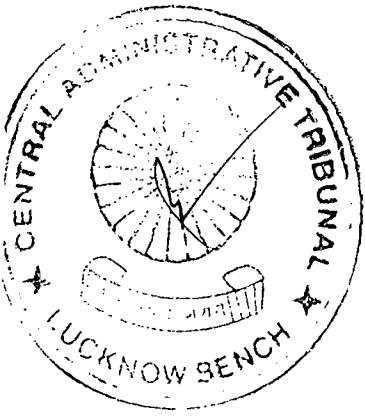

**ORDER (Oral)**

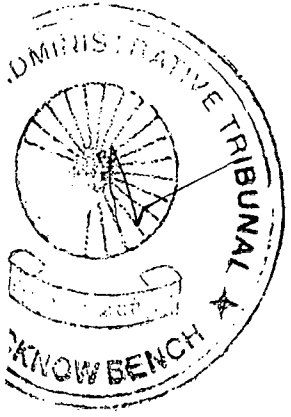
These O.As have been filed challenging the provisions of rule 5(3) of IAS( appointment by promotion) regulation, 1955 in so far as restriction of 54 years on the members of the State civil service in the matter of promotion to the IAS cadre. Reliance is placed upon the order of the Bangalore bench of the tribunal in OA No. 447 of 2007. The said bench quashed, by order dated 30-11-2009, the regulation 5(3) of the IAS( appointment by promotion) Regulation 1955.

2. Writ petition No. 39137 of 2009 was filed against the aforesaid order dated 30 - 11 - 2009 before the Karnataka High Court. The High Court passed an interim order dated 11 - 02 - 2010, whereby operation of the order dated 30 - 11 - 2009 passed by Bangalore Bench of the Tribunal was stayed and the Union Public Service Commission was allowed to proceed in the matter of promotion and consider the list of eligible officers.

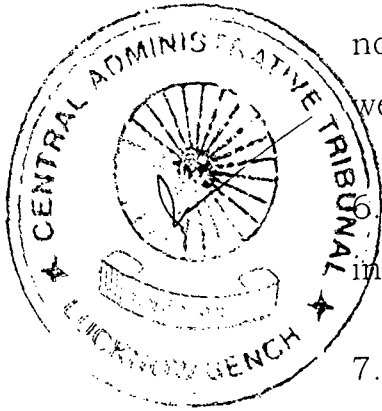
3. The aforesaid interim order passed by the Karnataka High Court was challenged before the Apex Court in S LP No. 7448-7460 of 2010 and the Apex Court passed the interim order dated 18-03-2010 whereby it was directed that the names of the petitioners shall also be considered but the sealed cover procedure shall be adopted.

4. OA No. 467 of 2010 was preferred before this Tribunal praying for their consideration in the DPC. This Tribunal rejected the Interim Relief prayer by order dated 29-10-2010.

5. The order dated 29.10.2010 was challenged by filing a Writ petition no. 1658 (SB) of 2010 before Lucknow Bench of Hon'ble High Court. The aforesaid Writ petition was allowed vide its judgment and order dated 2.11.2010 to the extent of providing parity with the interim order passed by the Hon'ble Supreme Court and directed the respondents that till adjudication of the controversy, the benefit of interim order of



Hon'ble Supreme Court shall be extended to the petitioners of the O.A., but it shall be subject to further order passed by Hon'ble Supreme Court or final adjudication of controversy by the CAT which ever is earlier. In the meantime, Hon'ble Karnataka High Court allowed Writ Petition no. 39137 of 2009 filed by Smt. Savithri M.V. Vs. U.O.I. and others alongwith other Writ petitions by which judgment and order dated 30.11.2009 passed by Bangalore Bench of the Tribunal was quashed and validity of Regulation 1955 was upheld. When this development was brought before the Hon'ble Supreme Court, it was pleased enough to pass a judgment and order dated 26.8.2011 in SLP no. 7448-7460 of 2010 by which these Special Leave Petitions were declared infructuous.



6. Learned counsel for the applicants states that he has no instructions from his clients.

7. In-view of the above on merits, no case is made out for interference.

8. All O.As are dismissed. Interim orders if any, passed earlier shall stand vacated. No costs.
