Pursuant to the order passed by the Tribunal vide dated 01.11.1996, the respondents vide their order dated 19.12.1996 promoted the applicants - Senior Accountants as Junior Accounts Officers on adhoc basis for a period not exceeding 180 days with immediate effect. They are promoted and posted on a purely temporary and local officiating basis with a special allowance of Rs. 50/- per month. The promotion will not bestow any claim for further promotion or seniority in the cadre of Junior Accounts Officer and the order is subject to the final outcome of the O.As. pending in C.A.T., Mumbai Bench. The applicants in these O.As. have prayed that they may be allowed to officiate as Junior Accounts Officers till the regular candidates are available.
