The applicants have sought the following reliefs:

"i) Direction upon the respondents to grant the scale of Rs.1640-2900 and allow the scale of Rs.6500-10500 w.e.f. 1.1.1996 being the appropriate replacement scale.

ii) Further, direction upon the respondents to create a cadre and provide avenue of promotion or take other steps to provide avenue of promotion to the Senior Hindi Translators."

As the cause of action and facts in the above OAs are similar, we propose to decide these cases by a common order.

2. Heard both the rival counsel and gone through the submissions carefully.

3. The applicants have not impugned any specific order passed by the respondents. They are presently in the scale of pay of Rs.5000-8000. The applicants are claiming that being Senior Translators (Hindi and English) and posted at the Naval Headquarters office, they are eligible to the higher scale of Rs.6500-10500 on the ground that there are two such scales in the Ministerial cadre including this. They have given details of work load and status of official cadres in different offices who have been enjoying similar higher scales, but the same has not been extended to them by the authorities. They have also given detailed facts and figures regarding the duties and work load as entrusted to the Translators and Senior Translators. Therefore, vis-a-vis others they have sought equities in their case, and vis-a-vis other Departments and cadres where and who have been given three scales (Rs.5000-8000, Rs.5500-9000 and

Rs.6500-10500)

4. The next point in their representation is that direction be given to the respondent authorities so that their work load are properly assessed and they get due consideration and their prospects for going up in higher scales improves. In this behalf, they have made several appeals through the Association namely Akhil Bharatiya Rajbhasha Karmi Sangh to the Cabinet Secretary. But, all this did not seemingly evoke any positive result. Even certain cases of inter-departmental variations in awarding of the scale to Translators and Senior Translators working in different departments have also been stated. For example Naval Headquarters have the scale of Rs.1640-2900, while the applicants working in Aaykar Bhavan are placed in the scale of Rs.1600-2660 since IVth Pay Commission. The equivalent scale of Rs.1600-2660 is Rs.5000-8000. Had they been initially equated with Translators working with the naval authorities, then they could have got replacement scale equivalent to of Rs.6500-10500 which is their claim.

5. In brief, the applicants have cited the recommendation of the Vth Pay Commission where the Translators who were in the scale of Rs.2000-3500 have been placed in Rs.7500-12000 and those who are Senior Translators in the scale of Rs.1640-2900 were given Rs.6500-10500 as there is no intermediate scale i.e. for Rs.1600-2660. They have asked for upgradation of their scale so that Senior Translators can be placed at a higher scale i.e. Rs.6500-10500. This is only prospective in respect of which they should have taken up their case with the Anomaly Commission or the respective department who normally engage themselves in such


exercise to remove anomaly and grievances of staff in the matter of fixation of pay scales.


6. The respondent authorities have brought to our notice that they have since then framed Recruitment Rules for Junior Hindi Translators, Hindi Officers, but for the Senior Hindi Translators, the process of framing Recruitment Rules is under active consideration. Though it is acknowledged that for Senior Hindi Translators Film Division have a different scale than the one enjoyed by them, but these anomalies are required to be reconciled through appropriate forum and the exercise is exclusive privilege of the department concerned. This process cannot be by-passed or over ruled by the Tribunal. They should be, therefore, asked to represent their case before the appropriate forum. We find that similar decision was taken when the matter was moved before the Hon'ble Supreme Court in the case of Union of India & Ors. Vs. P.V.Hariharan {1997 (3) SC 558}. It was held that fixation of - categorisation as class C held Tribunal's order fixing pay scale of respondent in category C was unsustainable. The Hon'ble Supreme Court observed as follows:

"Over the past few weeks, we have come across several matters decided by Administrative Tribunals on the question of pay scales. We have noticed that quite often the Tribunals are interfering with pay scales without proper reasons and without being conscious of the fact that fixation of pay is not their function."

7. In the circumstances, we find that these are demands for prospective fixation and not for removal of anomalies or illegality in fixation. In the situation, we find that this

Court, in this situation, cannot interfere in the matter, The OA is dismissed with a direction to approach appropriate forum and authorities for redressal of their grievances. No costs.
