






Combined seniority list of Staff Car Drivers of all departments in Mumbai Division dated 24/5/2000 at Annexure A is impugned by the applicant in the present OA. The said seniority list is provisional list and representations against the same have been invited. Applicants have infact submitted their representation on 19/6/2000 at Exhibit A-2. Without waiting for the response of respondents, the applicants have straightaway submitted the present OA.

2. In the circumstances, we do not find this a fit case to interfere at this stage. Present OA in the circumstance is summarily dismissed. It goes without saying that in case the respondents decide the representation against the interest of the applicant, it will then be open to them ~~applicants~~ to approach this Tribunal. Respondents are directed to decide the said representation expeditiously and in any event within a period of two months from the date of service of the copy of this order. Till such time aforesaid representation is decided, the respondents will not order promotions based on the aforesaid combined seniority list at Exhibit A. No order as to costs.
